These organizations have grown considerably since the Islamic Revolution in Iran. And many of these organizations are trying to women's rights and their participation in the development process of the country's growth and development have placed on its agenda. Hence, This study examines the impact of NGOs on women's political consciousness after the revolution. The results of this study suggest that NGOs can done a wide range of activities for the rights of women. Despite this , They have not succeeded in attracting women and their political awareness in the highly desirable. Nevertheless, Studies have shown that in many cases, these organizations have been successful in achieving women's rights.

Interior Ministry

NGO applies to all institutions by a group of natural or legal persons established as a voluntary non-governmental, non-political and objectives in accordance with its statutes track.

Center for Women's Participation

"NGOs: a set of interfaces in the form of NGOs and civil society organizations are composed of a group of volunteers and has the same purpose".

National Youth Organization

"Non-governmental and non-profit organizations that doing voluntary work with non-political tendencies only for compassionate purposes. These organizations have a special statute that is according to the executive branch".

Grassroots women's organizations can contribute to the growth and development of the country with attract women and increasing political- social awareness, and to make them believe and have faith in their ability by different ways such as training, information, counseling. Women's activity in NGOs can be considered both micro and macro levels :In micro-level, activities results for the one's own; In macro—level, women's activity checked in relation to the political system.

Impact of NGOs on awareness of women's political rights in Iran

Today, globalization, human rights discourse, women's rights activists and international NGOs growth of women's organizations at national and international levels. And on the other hand has increased political participation of women in management is become one of the main demands of women in the world, especially in the Muslim world (Women's Network).

With the formation of the Islamic Revolution and the Islamic culture in society, issues related to women's rights took on a new form. Many experts, including the founder of the Islamic Republic of Iran attention to the role and importance of women. This caused the women of the Revolution to gain confidence in political activities². After the Islamic Revolution in Iran, 1/5 percent of women selected parliament elections. While the fifth round of elections, the total number of delegates increased from 270 to 290 individuals¹.

Experience has shown that whenever the opportunity for women, women play their role and entered the field³. Although the level of specific political Participation of women is not significant in Iran; but in recent years, number of women who become members of political parties have been increased somewhat. So that in the Seventh 828 Female candidate for representative⁴.

Non-governmental organizations as one of the country's population structures can play an important role in the socialization of women for example, changes in beliefs about women's political culture. Women activity in the NGOs cause an increase in capabilities, increase the presence of women in society and their participatory experience – political. Women activity's in organizations makes sense that they would be useful (91 percent), as well as to increase their awareness of the problems of politics (67/3 percent). On the other hand, performance of many organizations are not clear to people. This indicates a failure to update these organizations. In women in NGO activities at the macro level, the attitude of the political elite, political culture- participation and civil society are important. Then, part of the failure of women's NGOs is related to ignoring them the government's activities. The result is that women's NGOs in Iran have failed to influence government yield too much⁵.

Impact of NGOs on social awareness of women's rights in Iran

With the formation of people's organizations and public bodies active and permitted presence of women in these organizations caused trust a lot of religious people that did not accept women in society before the Revolution. Today it is possible for women higher education, better jobs and achieving higher social identity².

The legitimate presence of women were recognized a top of the men. Female doctors, teachers, nurses and female drivers were trained. But social approach, women are among the vulnerable groups of society to provide their specific needs activities are supportive mainly. For this reason, most of them are some charities and cooperatives so role of this organizations cannot be ignored in the field of vocational training and job creation⁶.

Report of center for statistics and information of women's social and cultural, types of women's NGOs large increase from the mid-70s. Activities in this organizations on the need of society Including: subjects of art-cultural, sport, research, health, environment, vocational training and job creation, legal, religious funds, youth, social services, Social pathology, and network specialist. However, due to limited opportunities for formal employment, women engaged in informal employment such housekeeping services, sales, secretarial⁵.

Impact of NGOs on gender awareness of women's rights in Iran

Aspects altered awareness of women in most societies, in less than three decades is wonderful. The transformation process of gender socialization added in the presence of women in the public arena particularly in higher education. Although no significant changes in comparison with men. As Giddens writes: "In modern societies, women have the opportunity that test their chances in various fields. Since women have to lose previous and established his identity, then they experience modernization to form a more perfect and more contradictory" (Giddens; 2000).

Conclusion

This study examined the impact of NGOs on political awareness women's rights. The results of this study show that despite the efforts and activities of NGOs, these organizations have failed to have the desired performance yet. However, from the early days of the revolution, the government has done a lot of effort to increase the ability of women for better enjoyment of various social and political rights more importantly, education and literacy for women. But unfortunately, reflections of success both domestically and abroad is not as it should be. Obviously, assess the status of Iranian women with western values would not be desirable and
