Within the scope of criminal law, in accordance with Article 2 of the Islamic Penal Code of 1991: "Any act or detention which is punishable under the law is considered a crime". In fact, the crime in criminal law is defined in the law.

In the field of causal science of crime, fundamental theories of anthropology, biology, psychology and sociology have been raised. Based on each of these perspectives, physical defects, inheritance, mental disorders, society and its related factors can provide suitable grounds for criminality(Daly & Wilson, 1997; Rogers & Pilgrim, 2014). ### THE CONCEPT OF PREVENTION IN CRIMINOLOGY

Prevention in terms of etymology: (in the sense of pre laminating) is something to go and warn and warn(Bloom, 1995). In criminology, prevention is to prevent crime by using various interventions to prevent delinquency. In terms of science, it can be said that the prevention of any criminal policy activity is that for the exclusive or non-exclusive purpose of limiting the limits of the possible occurrence of a criminal offense through impossibility or difficult and making it difficult for them to occur without threatening a sentence or resort to it(Cao, 2012; Dahash, 2015).

It can be said that the number of criminological experts in the definition and classification (typology) of prevention has been presented(Mohammadi & Mehrabadi, 2016). Of course, division into social prevention and state-of-the-art is now the most famous division among the scholars of criminology(Modaberi & Momeni, 2016; Mohammadi & Mehrabadi, 2016).

Social prevention is a set of measures and precautionary measures that seek to eliminate or counteract the factors that affect the development of crime(Ekblom, 2017; Van Dijk & De Waard, 1991). Preventive measures address the circumstances, circumstances and circumstances that place the perpetrator at the brink of committing a crime. These conditions, which are called in the criminology of pre-delinquency or pre-trial situations, stimulate or facilitate the process of transition from thought to criminal action. And play a decisive role in it. Victim or crime target is one of these situations(Bjørgo, 2016). In the Prevention Bill: Crime Prevention is the anticipation, identification, and assessment of the risk of a crime, and adopting measures and measures to eliminate it. Or reduce it(Ishaq, 2016; Sidebottom & Tilley, 2017).

# **Social prevention**

In social prevention, criminal factors are first identified, then measures are taken to counteract or counteract the effects of those factors. In Islam, attention to the causes of the crime is greater than the attention paid to the victims, and Islam does not forget the causative and causal relationship between social factors and crimes-sins. The purpose of social prevention is to eliminate or neutralize those social factors that contribute to the development of the victim. Societal prevention signals the criminal origins and, by asking the people of the community and through various methods, monitor the causes and factors that are effective in finding the criminal thought(R. V. Clarke & Bowers, 2017).

In social prevention, the following factors are taken into account:

- 1. Increasing the awareness of individuals
- 2. Correct education of individuals
- 3. Eliminating the social context of the occurrence of crime is emphasized

Social prevention includes two parts:

- 1. Prevent the growth of the circuit
- 2. Environmental protection

Prevention of Growth Circuit (Early Prevention): Identify the requirements of different ages of growth, in relation to crime and crime, and identify ways to prevent future crime and to take preventive measures appropriate to any age.

Environmental Prevention: The policy and implementation approach is directed towards the social and personal environment of the individual, the pursuit of the environment, the sociality of man, is considered in preemptive criminology(Jaitman & Guerrero Compeán, 2015).

#### **Preventive Situation**

In the field of criminology and new prevention, there are more than local prevention and social prevention. Provisional positioning refers to a set of actions that take place in order to dominate the environment and the surrounding environment overlooking the crime as well as inhibition, in this way individuals or targets (the wealth of individuals and ...) from the victim Protect yourself(R. V. Clarke & Bowers, 2017). In this way, the person's condition or external conditions (place, time, etc.) are changed to prevent crime. In preventing a situation, attention is drawn to the pre-crime situation, and the process of moving from a criminal thought to a criminal act is stopped (passing from guilty to guilty)(Daskal, 2013; Van Brakel & De Hert, 2011).

The main art is in preventing situations, the ability to apply management, design and intervention in changing the environment, in which efforts are made to do something that the perpetrator needs more effort than before to commit the techniques that put the crime at risk. And reduce charm and pleasure(Sidebottom & Tilley, 2017).

Preventing someone from crimes is committed when there is a crime and we seek to prevent crime being repeated. An important part of denying the crime is to prevent the crime from committing it.

Preventing a situation means that before the crime, the offender must be dissuaded from committing a crime. For example, the car and house alarm setup(Jaitman & Guerrero Compeán, 2015).

Situational prevention theorists, including preventive methods, eliminate or reduce the attractiveness of stimulating devices and also eliminate factors that provoke or encourage the perpetrator(Akbar & Hossein, 2015).

Adoption of the claim that sexual attraction desecration of a victim reduces his vulnerability to crime is not so difficult because in the process of choosing a victim in this category of crimes, the apparent characteristics of the victim are seriously offended. For divorced children, according to since the family has lost the trust of the children, the children sometimes seek alternatives that are, of course, often caught up in profitable individuals. Sex crimes in many cases can be analyzed in the context of the supply and demand approach and the wise selection, which is one of the approaches to the sociological explanation of social deviations; in other words, the offender confirms the victim's role in the course of deviation and distortion(Jones, 2013; King & Roberts, 2017).

Technically and precisely, prevention prevents the abandonment of the "tool" and "opportunity" to commit a crime. To commit a crime, the community requires three factors, called the triangle of crime. It is necessary to take preventive measures to eliminate the criminal motive. What is prioritizing crime prevention is to keep the targets and the victims from harassing

criminals. Preventing a situation means adopting and taking measures against our circumstances before committing a crime and turning to the crime equation, preventing a victimized crime or socializing more criminal(King & Roberts, 2017).

### THE CONCEPT OF DIVORCE

In terms of divorce, the divorce is due to the marital relationship in a permanent marriage contract for the purpose of marital satisfaction, whether by a legal representative of a couple, such as the divorce of a permanent maiden by his wife(Barzoki, Tavakoll, & Burrage, 2015; Emami, 2015).

"Divorce" in the word means the separation of a woman from a man, getting rid of marriage and getting rid of marriage. Islam considers and attaches great importance to marriage as a sacred bond with various personal and social goals.; But divorces is considered unnecessary, and mentions a lot of guidelines for avoiding divorce ... The vast orders of Islam about tolerance and passing of husbands to each other and the suffering of economic failures and other marital problems indicate that Islam, even in the face of intolerant suffering, sees divorce and, as far as possible, prevent the collapse, the holy building of the family(Grillo, 2016) Historically, they also consider the divorce period as dating to marriage. According to the oldest legal text derived from the law "Hammurabi" of Babylonian civilization this right has been allowed for a man and under conditions for a woman(Duby, 1992).

Even before Christianity in ancient Greece, the divorce of the woman was not possible at first, except by proving adultery or intent on her husband's life. Yet since the year (411 AD), when certain laws were implemented, divorce was completely released to the man, and from this date onwards, the divorce rate in Rome, even among the Kaisers, rose sharply(Areen, 2014; Mishler, 2012). Before the advent of Christ, once again the conditions for divorce were considered. In "ancient Egypt" there was no condition for divorce, and the man could divorce his wife whenever he wanted. Among the followers of the "Buddha" man Divorce was divorced by his wife whenever he wished. In the midst of the Brahmins, divorce was prohibited, and it was quite common among the Arabs of Judah, and there was no limit to it. In the "Jewish" state, as long as the husband does not like his wife, he has the right to divorce him. In "Catholic Christianity", which is inspired by the laws of ancient Rome, there is no right for a man to divorce, and not for a woman, only when a woman commits adultery. A man can divorce him(Phillips, 1991).

### **DIVORCE**

It seems that this and the prohibition of both in preventing the occurrence Crime and the nature of crime, because we know marriage and marriage in many cases reduce the crime rate, and on the other hand divorce in some cases increases the crime rate between children and even divorced women.

Considering the high emphasis of Islam on marriage and avoiding divorce, this makes marriage easier, and vice versa, makes it harder for divorce ... Maybe it's because of the

breakdown of the family center, the background The distortion and corruption of family members (especially children) is threatened, which is in line with precautionary measures (Haeri, 2014).

Nearly 40 percent of women suffer from sexual disorders in adultery relationships(Barzoki et al., 2015). However, one of the most important functions and philosophies of marriage is to satisfy sexual needs. Paying attention to Quranic verses and recommendations of the Imams on this issue and the historical memory of nations and people of the family fortunately, it expresses the special role and importance of sexual need in the family(Emami, 2015; Ishaq, 2016).

In order to prevent divorce, proper and timely education of spouses during marriage can be largely prevented from their sexual distress and prevent the concentration of families from dissolution and, as a consequence, prevent the deviations of children. This With the approach to social prevention, growth can be implemented. "From 50 to 60 percent of the total population of Iran due to sexual disorders and problems, 59.3 percent of the prisoners from the age of 58 to 80 were women" (Aghajanian & Thompson, 2013).

Consideration of the education and counseling of premarital sexuality is one of the essential requirements in order to be able to ascertain, according to statistics, the sex of couples with a positive view of spirituality. In some of the teachings of the infallible (a) the reward of sexual relations is equivalent to some religious duties such as Jihad knows that it is the destruction of sins and the destruction of people(Stowasser, 1996). According to the traditions, none of the women should not even prolong their worship for their disobedience.

Perhaps some people at first say that the rewards of legitimate sexual relations are equal to jihad, but if we consider the statistics and causes of divorce and, on the other hand, the crimes that are caused by neglect of this issue, we will better understand the policy of Islam in this category. Islam is very beautiful and accurate in order to prevent the social and the social development of the circuit to prevent the occurrence of divorce, which is the prevention of divorce, the prevention of a large number of precarious and degrading crimes.

## **Divorce factors:**

The effect on women, especially those who do not have shelters, is difficult to deal with, but it is very dangerous. Other complications that women and men may face after divorce include: 1. Feeling of anger; 2. Feeling guilty; 3. Fear; 4. Frustration; 5. Feeling. Loneliness 6-The sadness of the loss of life and capital 7-Physical and psychological problems(Kalmijn, 2015).

Research shows that the effects of divorce depend on the age of the child when they are divorced. It also affects the child by gender, personality, degree of incompatibility, parent involvement and support for the family and friends of the child (Amato, 2014; Kalmijn, 2015; Mandemakers & Kalmijn, 2014). The reaction of children at pre-primary school age (2 to 5 years old) is anger and depression. The husbands are usually more unrelenting, violent, and devilish. In some cases they do not show the passion for playing with other children, in some cases they prefer to be alone. Some girls Less than thirty years of age, they become nervous, but others will treat older adults. Many 6 to 8 years of age are often after the separation of parents and children the boys' reaction is usually more intense than girls. The children's boys are soon crying and catching their father. Some 9 to 12 years old, after parental separation, show offensive reactions(Maccoby, Depner, & Mnookin, 2014).

According to research by criminologists and astronomers, most street children are single-minded, as well as street children and sleeping cartons, in other words, their parents are divorced or their father died. Increased self-care women and their livelihoods, psychosocial, social and moral issues, and other personal, social and affective issues of divorced children and their children are among the effects and social consequences of divorce(Amato, 2014).(Amato & Boyd, 2014; Kalmijn, 2015).

Often dangerous and addicted persons are those who do not form a single family. If married persons commit crimes, they should be considered as sources of crime, psychological problems and lack of education. The most common causes of separation of families, Absolute adherence to either of the parties, or one of them, is to marital law and sexual behavior (Haeri, 2014).

The Prophet (peace be upon him) said: "I was ordered to a woman about a woman who thought that divorcing a woman was not worthy of him except in the case of committing adultery." 27% of the divorce applicants in Iran have had a direct interference with their relatives and relatives because of their request for separation. Families and surrounding people should know that Islam, those who create disagreements between men and women or do things that may cause disagreements between them, is a promise of eagerness and agony(Aghajanian & Thompson, 2013).

Extreme differences between couples in religious beliefs and attitudes, high-risk antireligious behaviors, wine-making, sexual relations outside the family framework, the abandonment of religious duties and acts of hatred, humiliation and violence against the offender, suspicious accusations, foolishness, witchcraft, **Important** pessimism, etc. factors breakdown(Emami, 2015). In a fractured family, due to the loss of a parent or parent, due to natural or divorce, the child is faced with a feeling of failure, deprivation, lack of affection, and emotional attachment, and in some cases due to the rejection of the successor (Stepfather or stepfather) is the basis for behavioral disagreements like escape from the house, crime, etc. The statistics indicate that there are factors mentioned and other factors that have led to 16 cases of divorce per hour (equal to the official statistics of the news network) (94). Of course, these are formal divorces and divorces, the relationships are completely interrupted, but there are other statistics that may be referred to as black figures, the number of which is more than the one mentioned; and those divorces the emotion that increases in families is increasing day by day, causing deviations and mischiefs for husbands and children.

"The divorce rate for those who did not have an illegitimate relationship before marriage is 50% less than the others," said Jason Evert, "the divorce rate in couples Who have not had sex before the wedding, are three times less than the other couples" (Civic, 2009: 81). This point also requires careful consideration. In order to prevent divorce, it should also be taken into account that raising awareness and training of couples is significant (Social Enhancement of Growth Circuit).

### EMOTIONAL RELATIONSHIP BETWEEN PARENTS AND CHILDREN

Parents in the family should have adequate supervision over their children and have emotional connections with their children; the presence of parents in the family center is necessary and the absence of one will cause emotional distress in the child and turning him to victimization; Statistics and surveys confirm this. Parents are two elements that none of them alone can represent the divine mercy, but, by marrying these two, they are somewhat found acceptable, a source of mercy and righteousness, and the other is the manifestation of intensity. On the marriage of these two, the warmth of the family arises and, in the protection of the power and intensity of the father,

and the patience and mercy of the mother, the child finds divine education and becomes a divine Caliphate(Ishaq, 2016).

Research shows that about 70 percent of the causes of child escape are parents, so that from May to September, when teens cannot endure a family's disadvantage after school, they will escape from the facility in hopes of being in a better and more convenient environment. On the farthest month, when family members and family members are looking at the New Year and the New Year's celebrations, we see the least evasion. The statistics show that people who run away from the house are often between the ages of 14 and 25, and 80% of them prefer to leave the home due to incompatibility with their parents(Akbar & Hossein, 2015).

Mother's work is another cause of child abandonment and family deprivation if the mother no longer has enough time for her family. The phenomenon of working mothers emerged after World War II came from the thinking of the capitalist system, which severely undermined the family system in the West, and delivered generations of anonymity and lack of emotional backing (Weisberg & Appleton, 2015).

A Western study of the perpetrators showed that 91 percent of the perpetrators were in some way afflicted with emotion(Smeulers, 2015). According to psychologists, the mental disorders of people caused by a lack of affection appear in the following ways, each of which can provide grounds for diversion: weakness in self-esteem, embarrassment, and the likelihood of blind imitation, the need for attention and self-awareness through undesirable methods(Aghajanian & Thompson, 2013).

In general, between 30% and 90% of offenders in broken families, 24% in families separated by parenthood, 11% were due to lack of one of the parents and 11% due to parents' moral corruption (80%). If the family Children are vulnerable, children can be emotionally and kindly treated by their parents to avoid being victimized or infected in sexual deviations(Lee & Sun, 2017).

Parents who spend too much time praying on children over the past modesty, so to speak, will bring them back and forth, will unwittingly advocate for the diversion of their children. More attention may be distracted by his child(Barzoki et al., 2015; Maccoby et al., 2014).

According to the deputy director of the Center for Statistics and Statistics of the Women's Social Cultural Council of the Islamic Republic of Iran, the survey of the number of girls in high school education over the past decade has shown that the number of never-married girls with higher education has risen from 5% to 16%. The survey of the statistics center of Iran indicates that the rate of never-married girls with secondary education has risen from 26 percent in 75 to 42 percent in the year 85. The statistics show that high the drop in education has been a source of divorce in women and has led to less girls being married(Malekinejad et al., 2015). According to the Information and Statistics Center of the Women's Social Cultural Council, despite the fact that higher education has a negative impact on the increase Girls' marriage has taken place, but recent information provided by the Center for Statistics indicates that this trend has led to an increase in divorce The comparison of current statistics with a decade ago shows that divorce in the educated population has not risen significantly and is as high as the more educated society divorces, but in terms of the inertia of this meaningful relationship And the percentage of abandoned university students has increased substantially.

In Tehran, almost every three marriages, one leads to divorce. One point to note is that there is a significant relationship between single-parenting and rising divorce rates. Along with the decline in population growth and the rule of culture, the "child of a poorer life" in the country, we face an increase in the number; an increase in the growth of divorce, and especially in divorce agreements. This suggests that there is a significant relationship between single-child life skills and an increase in divorce rates, according to statistics, 70% of divorces are under 30(Malekinejad

et al., 2015). According to the existing figures, the highest number of divorce applicants, especially the divorce agreement, which expresses more rush to end the common life, is the late-childbirth of the 60s and the early years of the 1970s. It was right for the birthplace of propagandists and numerous preventive measures to reduce population growth and the single-child outbreak of the society. When these single-born children have reached the age of marriage and employment, their educational deficiencies have led them and their families to fail to learn how to interact with others. One way to prevent divorce, encouragement and persuasion Families have more than one child, so that children within the family experience certain behaviors and social norms or social abnormalities that we can classify in the prevention of the situation. Divorce figures, especially divorce agreements, have grown so much that the leader of Iran emphasized the need for a divorce reduction agreement with the efforts of judges and family elders during a meeting with the judiciary officials (Emami, 2015).

"There are 24 million young people in the country who, according to marriages registered in 93, out of these 24 million, 3.5% of them are in the country," said the deputy director of youth affairs at the Ministry of Sports and Youth at a press conference on the process of divorce and marriage in the country. Last year they married 740 thousand people(Barzoki et al., 2015).

The Deputy Minister of Youth Affairs of the Ministry of Sports and Youth, in a province like Sistan and Baluchestan, where there are economic problems, the ratio of marriage to divorce is 15, but in Tehran, almost every three marriages occur in a divorce, and this suggests; Divorce is not necessarily linked to economic indicators.

According to available reports and statistics, the need for life skills training for young couples is increasingly effective in reducing, preventing and divorcing. Familiarizing them with successful families and those with economic difficulties and ... have a good and successful life, all of which are tremendously effective. One of the points that leads to compromise divorces is single-parenthood Knows that, when the number of children in the family is more than one, they are practicing difficulties in the family, "not hearing" against the same They learn that one has the other to say "no" to them and behave differently from their desire, so these children will continue to live together in their common life if they encounter problems and if they do not understand, they will survive. Bring back(Aghajanian & Thompson, 2013).

Single children learn less social skills in the family; therefore, they usually have difficulty in family problems. Regarding the fact that in most single-parent families, unfortunately, maternal waists, and parents provided them with everything they wanted in life, as a result of which they, in their family life, had the exercises and skills necessary to solve their problems. They have not cried out, cried, and had problems. So less can be successful in a common life, such people in a common life when they want something that their spouse cannot prepare for them, they are upset, disappointed, and hateful, and this is because they already experienced They have not solved the problems, so this discomfort causes the husband to stay away, and in discomfort they say to their spouse, "We do not have an understanding and agreement, so it's better to separate from each other". Guys Many exercises on social interactions and problem solving should be experienced in their own realm, not just by their parents, so doing, the child, the skill to Does not.

# **CONCLUSION**

One of the important things that exist in human life is the formation of a family and its consolidation; unfortunately, in recent years this importance has diminished, and on the other hand, the dissolution of that day is on the rise; in This article was followed by the prosecution of the dissolution of the family (divorce), as it was previously said, divorce is not a crime, but

Of course Observing adolescents in divorce can also be seen as another way of preventing situations; if they are mistaken and regrettable, they will They refer to the important aspect of the future of divorce children, which threatens them with the risk of social, sexual and social deviance, forgiveness, and the forgiveness of couples' life should be their place, so that the families are firmly established every day. The more they are. It is said that couples should be made together and understood and respected each other. The use of the experiences of the elderly, especially the fathers and mothers, will also open the young couples to a large extent from divorce and subsequent deviations and delinquencies.
